Approval of Authorization Committees for removal and transplant of kidney Unrelated donor and recipient.

Donor : **Mrs. Mandabai Sunil Shelke.**

Recipient : **Mr.Ramhari Kashinath Sonawane..**

Order in the case of **Mr.Ramhari Kashinath Sonawane.,** Recipient of kidney from **Mrs. Mandabai Sunil Shelke.,** donor, under the Rule No.9, sub rule (5) of the Transplantation of Human Organs Act 1994.

The case regarding approval of unrelated kidney transplant of Recipient **Mr.Ramhari Kashinath Sonawane.** was scrutinized and discussed by the Authorization Committee in the meeting held on 22.02.2017 at 04.00 p.m.

In the affidavit **Mr.Ramhari Kashinath Sonawane.** aged 28 years resident of At.Post Bahirgaon Tq; Kannad, Dist: Aurangabad, Maharashtra stated that he has submitted the list of his close and nearest relatives along with their blood groups etc. He further stated that due to the reasons mentioned therein, they could not donate their kidney for him. His father is no more, Mother, wife, brother & one Sister are ABO mismatch & has two sons who are minors. Hence he has requested for undergoing kidney transplant with an unrelated donor.

The Authorization Committee interviewed recipient **Mr.Ramhari Kashinath Sonawane..** He said that he is suffering from kidney disease from 06 months. He is taking treatment at MGM Medical College & Hospital, Aurangabad. He further said that **Mrs. Mandabai Sunil Shelke.** who is his Mother in law is willing to donate her kidney to him on humanitarian grounds. There is no transaction of any sort.

In the affidavit sworn in by **Mrs. Mandabai Sunil Shelke.,** aged 46 years, Resident of Garaj Tq; Vaijapur, Dist: Aurangabad, stated that she is housewife and she is donating her kidney to her son in law out of love & affection.

The authorization committee interviewed **Mrs. Mandabai Sunil Shelke.** she said that she is donating her kidney to her son in law on humanitarian grounds purely because of affection for him. There is no transaction of any sort.

On Going through all Documents and Interview of donor and recipient and their relatives love and affection between them is proved. Donor was evaluated by the Authorisation committee for her understanding regarding the procedure, complications and risk involved including the risk of death during the transplant operation. Hence Authorization Committee appointed by the Government of Maharashtra vide Gazette extraordinary Section 4-A/ year 3, Numbr 7, dated 19<sup>th</sup> January, 2017, decided to grant NOC for kidney Transplant from Donor **Mrs. Mandabai Sunil Shelke.** and transplant to the recipient **Mr. Ramhari Kashinath Sonawane.** This approval is valid for a period of three months from the date of permission for the removal of the organ in your hospital only and by the medical practitioner (**Approved by the appropriate authority and Director of Health Services,**) named in your application. In case these conditions are not fulfilled the approval automatically becomes invalid.

**You are requested to submit the post-operative information alongwith photographs of donor and recipient of this case to this office and Director of Health Services, Arogya Bhavan, Maharashtra State, Mumbai.**
