- 2. Interested bidders shall visit and inspect the actual site/area particular rooms between 10.00 a.m. to 5.00 p.m. prior to last date of submission of tenders. Once the tender is submitted, no complaints regarding the work area will be entertained by this Registry.
- 3. The quoted rates must be excluding GST.
- 4. The agency should mention name and quantity of chemical/s to be used for the anti-termite treatment and also quote rates in the format given at Annexure "B". The agency will have to give written undertaking

that, after such a treatment, there will not be re-occurrence of termites for specific period. In the event of re-occurrence, it will have to take steps to eradicate the same, free of cost.

- 5. The successful agency/vendor will have to provide Pre construction anti-termite treatment, Post construction antitermite treatment, pest control services for mosquito, cockroaches, bed bug, rodent, ant & honey bee removal with proper care and caution, so that no damage is caused to the life & Property, including documents/record of this Registry. In case the damages/loss is found to have cased after treatment to the lives/record/documents of this Registry, the agency/vendor shall be totally responsible for the same and the appropriate action shall be taken against the agency, as may be decided by the management.
- 6. The bidders should submit a Rs.1,000/- + GST for tender purchase. NEFT/RTGS AC No. 76102000029616 IFSC Code No. IBKL0000376.
- 7. Security Deposit:-The successful Bidder shall at his own expenses submit an unconditional and irrevocable FDR or DD, as a security deposit for Rs.15,000/- of any Nationalized Bank with Tender Issuing Authority in favour of MGM Campus, within fifteen (15) working days from the date of work order, The said Bank Guarantee will be returned to the successful bidder on successful completion of contract period. - 14. The Chemical should be purchased form Authorized Distributor of Manufacture from Maharashtra Region.
- 15. In case the service is found to be unsatisfactory, the contractor will be terminated without assigning any reason and forfeited the EMD & you will be blacklisted.
